## **Illinois Energy Conservation Advisory Council Vacancy Notice Representative of a Group that Advocates for Energy-Efficiency with Technical Expertise in Single-Family Residential Buildings**

CDB is seeking to fill a new position of the Illinois Energy Conservation Advisory Council. The position is for a person representing a group that advocates for energy efficiency in single family residential buildings. This position was added to the Council in [Public Act 102-0662, the Energy Transition Act](#).

The Illinois Energy Conservation Code is based on the International Energy Conservation Code. The purpose of the Council is to recommend Illinois specific modifications to the International Energy Conservation Code.

The nominations for appointees must come from organizations that advocate for energy efficiency and cannot come from individuals. The nominee should be a person actively involved in an energy efficiency field related to single family residential buildings and have experience with the Illinois Energy Conservation Code.

1. A letter from an organization that advocates for energy efficiency nominating an individual for this position. The letter should include information about the individual and why the organization feels they are a qualified candidate including the candidate's experience with single family homes.
2. A resume for the nominee.
3. A letter from the nominee explaining why they would like to be appointed to the Council and what experience/knowledge they have which makes them a good candidate. It should also relay information about their experience with single family dwellings.

CDB will accept submittals through December 31, 2021. All submittals will be reviewed and the CDB Executive Director will determine the appointee based on the qualifications of the candidates.

This is a non-paid position, but council members shall be reimbursed for reasonable travel expenses necessarily incurred in the performance of their duties.
