## Illinois Energy Conservation Advisory Council Vacancy Notice

CDB is seeking to fill multiple vacancies of the Illinois Energy Conservation Advisory Council. The composition of the Council is defined in [71 Illinois Administrative Code 600](#).

The Illinois Energy Conservation Code is based on the International Energy Conservation Code. The purpose of the Council is to recommend Illinois specific modifications to the International Energy Conservation Code for incorporation into the Illinois Energy Conservation Code and the Illinois Stretch Energy Code. The following vacancies will be filled:

- There is 1 position for an **Energy-Efficiency Advocate – Single Family Residential Buildings**. The nominations for appointees must come from organizations that advocate for energy efficiency and cannot come from individuals. The nominee should be a person actively involved in an energy efficiency field related to single family residential buildings and have experience with the Illinois Energy Conservation Code.
- There is 1 position for an **Energy-Efficiency Advocate – Multifamily Buildings**. The nominations for appointees must come from organizations that advocate for energy efficiency and cannot come from individuals. The nominee should be a person actively involved in an energy efficiency field related to multifamily buildings and have experience with the Illinois Energy Conservation Code.
- There is 1 position for an **Energy-Efficiency Advocate - Commercial Buildings**. The nominations for appointees must come from organizations that advocate for energy efficiency and cannot come from individuals. The nominee should be a person actively involved in an energy efficiency field related to commercial buildings and have experience with the Illinois Energy Conservation Code.
- There is 1 position for **Environmental Justice**. The nominations for appointees must come from organizations that represent environmental justice and cannot come from individuals. The nominee should be a person actively involved in the environmental justice field and have experience with the Illinois Energy Conservation Code.
- There is 1 position for an **Advocate for the Environment**. The nominations for appointees must come from organizations that represent environmental concerns and cannot come from individuals. The nominee should be a person actively involved in an environmental advocacy position and have experience with the Illinois Energy Conservation Code.

- There are 2 positions for persons representing the **Commercial Construction Industry**. The nominations for appointees must come from organizations that represent commercial contractors and cannot come from individuals. The nominee should be an active commercial contractor and have experience with the Illinois Energy Conservation Code.
- There is 1 position for a **Mechanical Engineer**. The nominations for appointees must come from organizations that represent engineers and/or engineering design firms and cannot come from individuals. The nominee should be an active Illinois licensed mechanical engineer and have experience with the Illinois Energy Conservation Code.
- There is 1 position for an **Electrical Engineer**. The nominations for appointees must come from organizations that represent engineers and/or engineering design firms and cannot come from individuals. The nominee should be an active Illinois licensed electrical engineer and have experience with the Illinois Energy Conservation Code.
- There are 2 positions for **Architects**. The nominations for appointees must come from organizations that represent architects and/or architectural design firms and cannot come from individuals. The nominee should be an active Illinois licensed architect and have experience with the Illinois Energy Conservation Code.
- There are 2 positions for **Building Code Officials**. The nominations for appointees must come from organizations that represent local code officials and cannot come from individuals. The nominees should be an active code official and have experience with the Illinois Energy Conservation Code.

1. A letter from the sponsoring organization nominating an individual for the position. The letter should include information about the individual and why the organization feels they are a qualified candidate.
2. A resume for the nominee.
3. A letter from the nominee explaining why they would like to be appointed to the Council and what experience/knowledge they have which makes them a good candidate.

CDB will accept submittals through February 28, 2026. All submittals will be reviewed and the CDB Executive Director will determine the appointee based on the qualifications of the candidates.

This is a non-paid position, but council members shall be reimbursed for reasonable travel expenses necessarily incurred in the performance of their duties.
