 - a. REVISE to read: "CONTRACT ADMINISTRATION FEE: A contract administration fee (CAF) is applicable to each contract in accordance with Article 00 21 40 of the Standard Documents for Construction. The assessed amount will be included in the Notice of Award Letter. The 3% CAF will be added to the overall proposal amount and included in the contract when executed. It should not be added into the bid amount by the offeror".

attenuation in accordance with local jurisdiction requirements. A minimum of two 4-pole ATS shall be provided downstream of the generator (life safety loads to be on their own ATS and electrical distribution). Generator shall be grounded as separately derived system. The emergency system shall include permanent switching means to connect a portable generator to supply power to life safety items in the event of maintenance and/or repair of the permanent generator".

- 3. Section II-9 Basis of Design: Electrical + Lighting. 9.1- 9.101:
 - a. REPLACE this section in entirety with the attachment "II-9 Basis of Design Electrical_Lighting".
