REQUEST FOR PROPOSAL:

REVISE Section 00 21 16 .6:

a. REVISE to read: "Funds available for design and construction: \$15,716,368. These funds are provided by the Capital Development Board / Build Illinois Bond fund (0971)".

INSERT in Section 00 21 16.16

a. **FF&E Purchasing:** NIU will purchase the FF&E using the allotted \$404,016 FF&E allowance. The Design-Build team should not include the purchasing of FF&E in the pricing schedule. The Design-Build team is responsible for design, selection, and specification of FF&E, coordinating with NIU. Illinois Public Higher Education Cooperative (IPHEC) pricing is preferred but not required. The Design-Build team is responsible for the design, coordination, installation of FF&E utility hook-ups and connections, and installation of FF&E. The Design-Build team must include the utility hook-ups and installation in the Design-Build Pricing Schedule. IPHEC manufacturer and vendor information can be found at https://www.iphec.org/about-us. This amendment supersedes the responses to Phase 2 RFIs #26 published on 11/25/2025 and Phase 2 RFIs #6 published on 12/05/2025 regarding the purchasing of FF&E.

REVISE Section 00 42 10 .3.A.4):

a. REVISE to read: "CDB will pay a stipend to each unsuccessful shortlisted firm that provides a responsive/responsible Phase II Proposal and completes the interview process. Firms shortlisted to participate in Phase II will be required to enter into a contract with the Capital Development Board before submitting their Phase II

proposals. The purpose of this contract is to facilitate disbursement of the predetermined stipend after a Design-Build Contract has been executed between the successful firm and CDB for delivery of the project. The stipend amount for this project will be: \$10,429.82."
