  - a. .2 – Qualification Submittal Contents (Proposal Part I): Delete the text “fire protection, communications systems” from the 4<sup>th</sup> bullet point in subparagraph C.2.
  - b. .3 – Technical & Cost Proposal – Submittal Contents (Proposal Part II):
    - i. Delete the following text from the last bullet point on page 11; “fire protection, communication systems”
    - ii. Insert the text “if applicable” after “construction manager” in the first line of text on page 12.
- 3. Section 00 51 01 – PART I EVALUATION CRITERIA:
  - a. .2.F: Delete the text “LEED documentation facilitator” from the third line of this subparagraph.
  - b. .3.B: Delete the text “military facilities, HVAC, college campuses, correctional facilities,” and replace with “IDOT facilities, transportation material storage facilities,”
